WALK WITH ME CONSENT FORM

WALK WITH ME is a tool to help young people meet with and share questions, celebrations and insights with an older Christian.

This WALK WITH ME programme is being run by **NAME OF YOUR ORGANISATION**

How it Works

- 1 or 2 young people meet for an hour every couple of weeks with a committed Christian (Mentor) to catch up, discuss the bible, and pray.
- Mentors are recruited, trained, verified and supported by name your church, centre or organisation and use the WALK WITH ME app to help catch up, ask great questions and focus the time together.
- Pairs follow a 6 session "Journey" and will meet in (fill in what best describes your setting). Between meetings, they will read the Bible and act on what's being discussed.
